It is a requirement of the Equality Act 2010 for all schools to have an accessibility plan. This Accessibility Plan is drawn up in compliance with current legislation and requirements as specified in the Equality Act 2010 and Department for Education (DfE) guidance.

The Equality Act 2010 replaced all existing equality legislation, including the Disability Discrimination Act. The effect of the law is the same as in the past, meaning that "schools cannot unlawfully discriminate against pupils because of sex, race, disability, religion or belief and sexual orientation".

According to the Equality Act 2010 a person has a disability if he or she has a physical or mental impairment, and the impairment has a substantial and long-term adverse effect on his or her ability to carry out normal day-to-day activities.

The purpose of this plan is to:

- Increase the extent to which students with Special Educational Needs and Disabilities can participate in the curriculum
- Improve the physical environment of schools within The Gallery Trust to students with Special Educational Needs and Disabilities to take better advantage of education, benefits, facilities and services provided
- Improve the availability of accessible information to students with Special Educational Needs and Disabilities
- Ensure that parents have access to appropriate areas of school buildings for the purpose of attending assemblies, celebrations, parents' evenings and meetings

The Gallery Trust and all member schools strives to provide access and opportunities for all students without discrimination of any kind, irrespective of their SEND.

Below is an action plan showing how schools in the Trust will address the priorities identified in the plan, anticipating the need to make reasonable adjustments to accommodate students' needs. The Trust will encourage schools to make reasonable adjustments in their delivery of meetings, events or functions which would accommodate a greater number of parent / carer participation. For example, holding parents evenings in a central and accessible location i.e. the Hall. This is not limited to physical requirements but may involve using technology to make virtual participation an option.

The Trust is committed to providing school facilities that meet the needs of the children according to their EHCPs and endeavours to adapt to any changes in a timely manner. Many of the schools within the Trust have been purpose built to support their cohorts, meeting Part M requirements of Building Regulations and designed to the standards under BB104. Schools acoustic performance within these buildings will have conformed to BB93 at the time of their construction.

The Trust's Context

The Gallery Trust is a Special Multi-Academy Trust, and operates schools catering for pupils with a range of Special Educational Needs and Disabilities.

All pupils have an Education Health and Care Plan.
